## GENERAL INFORMATION:

BIOPOINT™ UNCHAINED is an impregnated dry fertilizer additive that provides the essential micronutrient, zinc in combination with unique technologies to enhance the availability of applied nutrients.

## DIRECTIONS FOR USE & APPLICATION RATE

2 qt (64 oz) per ton of dry phosphorus, potassium, micronutrients and fertilizer blends.

For use with urea, please apply BIOPOINT UNCHAINED on dry phosphorus or potassium and blend with urea after drying.

## FIRST AID

**If in eyes,** hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.

**If in contact with skin,** take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.

**If ingested,** have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

**If inhaled,** move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth (if possible).

## PRECAUTIONS FOR SAFE HANDLING

Use with adequate ventilation. Avoid inhalation of dusts, vapors, and sprays. Wear personal protective equipment (eye protection and gloves) to avoid contact with eyes, skin, and clothing. Open the container carefully; contents may be under pressure. Avoid prolonged exposure. Wash hands thoroughly after handling this product and before eating, drinking, and/or smoking.

## CONDITIONS FOR SAFE STORAGE

Store product in dark fiberglass or plastic containers out of direct sunlight or UV light. PROTECT FROM FREEZING. Keep containers tightly closed when not in use. Store in a cool, dry, well-ventilated area, preferably in a locked storage area away from children, feed and food products, and seed. Do not contaminate water, food, or feed by storage or disposal. Triple rinse container prior to recycling or disposing.

Dispose of contents/container in accordance with local, state, and federal regulations.
