<b>RICE</b>	Flag Leaf: 1-2 qt (32-64 fl oz) per acre
<b>SOYBEANS</b>	3rd-4th Trifoliolate: 1 pt (16 fl oz) per acre Early Pod Set Stage: 1-2 qt (32-64 fl oz) per acre
<b>WHEAT</b>	Dormancy Break: 1-2 qt (32-64 fl oz) per acre
