ProfitPoint NKB-S is a 4-0-20 fertilizer containing 5% sulfur, formulated to prevent/correct potassium and/or sulfur deficiencies. It can be applied alone or mixed with other fertilizers for soil incorporation. **ProfitPoint NKB-S** is intended to provide essential plant nutrients and enhance nutrient uptake and mobility. Use as a supplement to a regular fertilizer program. Utilize a jar test if compatibility is questionable.

DIRECTIONS FOR USE + APPLICATION RATE

FOLIAR: 1-4 qt (32-128 fl oz) per acre in a minimum of 2 gal of water.
SOIL APPLIED: 1-10 gal (128-1280 fl oz) per acre as required by soil analysis

STORAGE AND DISPOSAL

Store in a cool, dry place in original container. DO NOT FREEZE. Keep container tightly closed. Do not reuse empty container. Triple rinse then offer for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state, and federal regulations.
