# N-SNARE

### GENERAL INFORMATION:

STAYPOINT™ N-SNARE is an additive that extends nitrogen availability and uptake in addition to reducing nitrogen loss. It is intended for use as an additive to anhydrous ammonia and liquid fertilizer.

### APPLICATION RATES:

**Anhydrous Ammonia:** Use 6 oz. of STAYPOINT N-SNARE per 50 units of Nitrogen, up to a maximum use rate of 24 oz. per acre of STAYPOINT N-SNARE.

**Liquid Fertilizer:** Use 2 quarts of STAYPOINT N-SNARE per ton of UAN (28%–32%) \*See dealer for specific recommendations.

**Liquid Manure:** 24–32 oz. STAYPOINT N-SNARE per acre.

### DIRECTIONS FOR USE:

**Anhydrous ammonia:** Operator must follow all anhydrous safety precautions. Inject STAYPOINT N-SNARE through liquid fill valve. If pressure exceeds 150 psi, inject through liquid withdraw valve. Proper maintenance is required. Flush valve thoroughly with anhydrous. Coat fill valve thoroughly with a petroleum or silicone based lubricant. Apply treated anhydrous using conventional anhydrous application equipment.

**Liquid Fertilizers:** Liquid fertilizers containing high levels of phosphate should not be used with STAYPOINT N-SNARE. If pesticides are added to the tank mix in conjunction with liquid fertilizers, a compatibility jar test should be performed.

### STORAGE AND DISPOSAL:

Store in a cool, dry place. Store in original container. Keep container tightly closed. Do not reuse container. Triple rinse, then offer for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state, and federal regulations.
