DIRECTIONS FOR USE

GENERAL INFORMATION: SPRAYPOINTMS is a 34.0% liquid ammonium sulfate solution designed to increase herbicide performance through:

- Increased absorption into the plant's phloem through the leaf cuticle
- Decreased herbicide antagonism due to calcium ion mineralization

Prior to use read and follow all directions on this label and on the label of the tank mix partner(s). The tank mix partner's label(s) for specific usages and restrictions have precedence over the DIRECTIONS FOR USE referred to on this label.

USE RATES

Each gallon of SPRAYMS contains 3.4 pounds of ammonium sulfate. To meet various label recommendations, include:

- 2.5 gallons of SPRAYMS per 100 gallons to equal 8.5 pounds of ammonium sulfate per 100 gallons.
- 3 quarts per acre of SPRAYMS to equal 2.5 pounds of ammonium sulfate per acre.

1.2 quarts of SPRAYMS is equal to 1 pound of ammonium sulfate.

MIXING

SHAKE WELL OR RECIRCULATE BEFORE USE

1. Fill sprayer 1/3 to 1/2 full of water
2. Add Valcheck AMS to the agitating spray tank
3. Add dry flowables or dispersible granules
4. Add emulsifiable concentrates
5. Continue to agitate until tank is full

STORAGE AND DISPOSAL

Storage: Store above 0° F. If stored below freezing, shake well or recirculate before use. Keep containers tightly closed. Store in original container. Do not allow water or other chemicals to be introduced into contents of container. Do not contaminate water sources with equipment wash water, spray disposal wastes, or by cleaning of equipment. Do not store near feed or food products. Do not use or store near open flame.

Disposal: Do not reuse product containers. Triple rinse (or equivalent), then offer for recycling at an ACRC site (go to <http://www.acrcycle.org/> for locations) or by reconditioning, or puncture and dispose of in a sanitary landfill or by other procedures approved by local, state, and federal regulations.
