### GENERAL INFORMATION

SprayPoint LAST PASS adjuvant contains an NPE-free surfactant and is designed to enhance fungicide and insecticide applications and may be used with herbicides and other crop protection products. SprayPoint LAST PASS is an Enlist One<sup>®</sup> and Enlist Duo<sup>®</sup> approved adjuvant.

SprayPoint LAST PASS helps optimize droplet adhesion, which reduces bounce and increases droplet spreading for improved contact, coverage and canopy penetration. These features lead to enhanced agronomic performance that provide more fungicide and insecticide where it is needed the most.

### USE RATES

For use with fungicides and insecticides and may also be used with herbicides and other crop protection products. Prior to use, read all directions on this label.

Ground application: 6-10 oz per acre

Aerial or Drone application: 0.3% v/v (use 1.2 oz per acre with 3 gallons of water or less)

Before mixing pesticides with SprayPoint LAST PASS, conduct a jar test to determine compatibility.

### MIXING

Add SprayPoint LAST PASS after pesticides or other adjuvants are added but prior to complete fillingofthespraytank.

May be used through direct, in-line injection.

Do not mix SprayPoint LAST PASS with other adjuvants in an induction system or container when all the products are undiluted. Once mixed in water, all products are compatible.

#### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage, disposal or cleaning of equipment. **Storage**: Store in original container only and keep sealed, in closed storage areas. Storage above freezing is recommended.
